### SECTION 53 OF THE WILDLIFE AND COUNTRYSIDE ACT 1981

#### DEFINITIVE MAP AND STATEMENT OF PUBLIC RIGHTS OF WAY FOR THE FORMER CARRICK DISTRICT AREA THE CORNWALL COUNCIL (ADDITION OF A FOOTPATH AT WHEAL FRIENDLY IN THE PARISH OF ST AGNES) MODIFICATION ORDER 2020

The above order made on 13 February 2020 if confirmed as made, will modify the definitive map and statement for the area by:

Adding a length of Public Footpath in the Parish of St Agnes commencing at Footpath Number 1 St Agnes approximately 15 metres east of 'The Old Changing House' at Ordnance Survey Grid Reference (OSGR) SW 7199/5117 shown as point 'A' on the Order map then running in a generally northerly direction for a distance of 126 metres to a junction with Footpath Number 1 St Agnes at OSGR SW 7201/5127 shown as point 'B' on the Order map, then running in a generally north-westerly direction for a distance of 44 metres terminating at its junction with Unclassified Road U6074 'Rocky Lane' approximately 126 metres north of 'The Old Changing House' at OSGR SW 7199/5129 shown as point 'C' on the Order map.

Further copies of the order as made and the order map have been placed and may be seen free of charge at the Offices of Cornwall Council at Redruth Library and Information Service, Clinton Road, Redruth, TR15 2QE from 9.30 am to 5.00 pm on Tuesday, Thursday and Friday and from 10.00 am to 1.00 pm on Saturday and at the Truro Information Service, Pydar House, Pydar Street, Truro, TR1 1XU from 9:00 am to 5:00 pm on Mondays to Fridays inclusive (Public and Bank Holidays excepted). Copies of the Order and map may be bought there, at the price of £5.00.

Any representation about or objection to the Order must be sent in writing to the Countryside Access Team Leader, Cornwall Council, Pydar House, Pydar Street, Truro, TR1 1XU (quoting Reference WCA 583) not later than 2 April 2020, stating the grounds on which they are made. If no representations or objections are duly made to the order, (or to any part of it), or if any so made are withdrawn, the Cornwall Council, instead of submitting the order to the Secretary of State (or part of it if the authority has by notice to the Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the order (or that part of the order). If the order is submitted to the Secretary of State (in whole or in part) any representations or objections which have not been withdrawn will be sent with it.

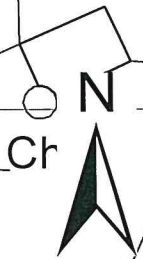
