

Q1 Are you a permanent resident in the Parish?


Q2 Do you consider there to be an issue with a lack of available parking spaces at Trelawny car park on a regular basis?





1	The problems of parking in St Agnes will not be resolved until money is spent providing additional space. Without that, all changes to the existing situation will be tinkering at the edges, where one solution here creates another problem there. For instance, limited stay parking at Trelawny will simply move the long-stayers on to the streets. Street parking is already problematic because of the lack of regular enforcement of restrictions. The central issue seems to be long-stay parking. Long stay users are likely to be those who: live in the village but have no domestic parking space; live elsewhere but commute into the village; stay in local holiday homes which lack parking. Not all drive off elsewhere each day, but will leave the car and walk or cycle. There three above groups need parking within easy walking distance of their homes. The following also require parking, but it could be outside the village: visitors and others taking extended walks around the area; wish to share transport to work in, say, Truro, leaving the unsued vehicles behind; wish to park in St Agnes and catch public transport to take them onwards - or to cycle. There is no space in the older core of the village, other than areas like the Garden of Rest or the Whitworth's field off Pengarth Rd, the loss of which green spaces would diminish the village environment. One smallish area which could be considered for parking use is the land between the upper end of Polbreen Close and the rear of White's Close Home. Meanwhile built up areas are expanding rapdily and substantially along Penwinnick Rd and a solution should be found by which to acquire land for a long-stay car park there, ideally in the very near future before every available field is built upon. Behind Penwinnick farmhouse would seem suitable, for example. I believe that the A30 dualling project is providing money for a safe cycleway to Truro as well as other enhancement projects.
