## Please note the following information:-

As of 1<sup>ST</sup> January, 2023

- 1. Weekend /Bank Holiday Funerals are subject to a further 50% surcharge on all fees/charges and payments, and **can only** take place if **agreed/confirmed** with the Sexton
- 2. Non-Parishioners see details below.
- 3. Unless a grave has been reserved by the Grant of Exclusive Right of Burial, all graves are taken in rotation.

Graves:- size of base 8' x 3'6"

Grave depths:- **Single** 4'6" **Double** 6'6" **Triple** 8'(extra payment)

The fees, payments and charges set out below apply where a person to be interred or in respect of whom the right is granted was an inhabitant or parishioner of the Parish of St. Agnes, or in the case of a still born child, where one of the parents is, or at the time of interment was, such an inhabitant or parishioner. In the event of a body of a child being interred in the same coffin as the body of its mother, no fees shall be payable in respect of the burial of such child.

## **Non-Parishioners**

In respect of interments, the whole of the fees, payments and charges will be trebled in the case of any person who at the time of death was not a Council tax payer or resident of the Parish of St. Agnes. However, persons residing outside the Parish at the time of death, but who had lived within the Parish in the last 5 years are treated as Parishioners. On written application, the Parish Council will consider waiving the requirement for treble fees in any case when the deceased had been a parishioner for a substantial and continuous period of their lifetime.

### **Grant of Exclusive Right of Burial**

For the reservation of plot, including the preparation of the Deed of Grant.

The above charge is for reserving a grave out of sequence and a certificate is issued. The purchase of grave space and the one-off maintenance fee must also be added. The Interment charges are payable at the time of subsequent deaths.

Where a grave has not been pre-purchased the above interment fees are in addition to the cost of purchasing the grave and the one off maintenance fee.

#### **Memorials**

A detailed drawing/description of the proposed memorial/inscription, with dimensions, is required in order to obtain permission. Work can only be carried out by Persons/Companies registered with the Parish Council.

#### Permits for memorials are only for 30 years and can be renewed.
